**1. Description:** The Written Procedure in accordance with Article 7 of the Rules of Procedure of the JMC of the INTERREG-IPA CBC Bulgaria – Turkey Programme for approval of amendment of Pre-contracting report from the performed on the spot visits to the projects with works component and budget optimization and projects' content modification of the projects provisionally selected for financing and included in the reserve list under the Second Call for Proposals of the INTERREG-IPA CBC Bulgaria - Turkey Programme 2014-2020, was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 15 May 2020.
