Description: The Written Procedure in accordance with Articles 7 of the Rules of Procedure of the Joint Monitoring Committee (JMC) of the INTERREG-IPA CBC Bulgaria - Turkey Programme for approval of Evaluation reports under Step 1 (Preliminary session), Step 2 (Administrative compliance and eligibility check) and Step 3 (Technical and quality assessment) for performed assessment procedure of one strategic project selected for funding under the Restricted Call for strategic project proposal of the Interreg - IPA CBC Bulgaria - Turkey Programme 2014-2020 was initiated by the Managing Authority - Ministry of Regional Development and Public Works, Bulgaria on 10.09.2020.

The official letter No. 99-00-2-238_10.09.2020 with proposal of the Assessment Working Group (AWG) the strategic project with reference No CB005.3.12.001 with lead partner "Prof. D-r Asen Zlatarov" University of Burgas to be financed under condition LP to provide complemented consent of the owner and the attachments: Evaluation report under Step 1 - Preliminary session and verification of submitted proposal under the Restricted Call for strategic project proposal of the Interreg - IPA CBC Bulgaria - Turkey Programme 2014-2020 (Attachment 3); Evaluation report under Step 2 - Administrative compliance and eligibility check under the Restricted Call for strategic project proposal of the Interreg - IPA CBC Bulgaria - Turkey Programme 2014-2020 (Attachment 4) and Evaluation report under Step 3 - Technical and quality assessment under the Restricted Call for strategic project proposal of the Interreg - IPA CBC Bulgaria - Turkey Programme 2014-2020 (Attachment 5), were sent to the JMC members via e-mail and made available in the JMC section of the Management Information System.

The JMC members were given 5 (five) working days to send their approval or comments of the aforementioned proposals.

 2. JMC approves the Evaluation report under Step 2 - Administrative compliance and eligibility check under the Restricted Call for strategic project proposal of the Interreg – IPA CBC Bulgaria – Turkey Programme 2014-2020;
 3. JMC approves Evaluation report under Step 3 - Technical and quality assessment under the Restricted Call for strategic project proposal of the Interreg – IPA CBC Bulgaria – Turkey Programme 2014-2020;
 4. JMC gives mandate to the Managing Authority to sign a subsidy contract with the strategic project with reference No CB005.3.12.001 with lead partner "Prof. D-r Asen Zlatarov" University of Burgas under condition LP to provide complemented decision of the university academic council clearly stating that all the assets, subject to intervention under the project are given for free right of use for the purpose of the project at least for 5 years after the end of the project (Consent of the owner).


