1. Description: The Written Procedure in accordance with Articles 7 (1) and 7 (2) of the Rules of Procedure of the JMC of the INTERREG-IPA CBC Bulgaria – Turkey Programme for approval of the Annual Implementation Report (AIR) for 2019 under Interreg - IPA CBC Bulgaria - Turkey Programme 2014-2020 was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 03.09.2020.


