1. Description:

The Written Procedure in accordance with article 4, paragraph 2(d) and article 7 of the Rules of Procedure of the JMC of the Interreg-IPA CBC Bulgaria – Turkey Programme for **approval of request for extension of project implementation period of the project “Promotion of the historic, cultural and touristic treasures of Edirne and Nessebar” with reference number CB005.1.21.128, subsidy contract № RD-02-29-39/20.03.2017** was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 11.06.2018.


