1. Description:

The Written Procedure in accordance with Articles 7 (1) and 7 (2) of the Rules of Procedure of the JMC of the Interreg-IPA CBC Bulgaria – Turkey Programme for approval of the proposal for financing of project proposals from the reserve list under the 2nd Call for Proposals, was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 19 September 2019.

The official letter No. 99-00-2-432/19.09.2019 with the proposed documents were sent to the JMC members via e-mail and made available in the JMC section of the Management Information System.

Based on analysis of the available funds and level of achievement of Programme output indicators with financed under the First and Second Call for Proposals projects, prepared by Managing Authority and National Authority, 14 applications proposed for financing under PA 2 at the total amount of EUR 3 273 423,42 were presented.

The JMC members were given five working days to send their approval or comments on the proposed documents.

Comments and approvals of the proposal for financing of 14 project proposals from the reserve list under the Second Call for proposals were received from Ministry of Foreign Affairs, Republic of Bulgaria and Ministry of Foreign Affairs, Republic of Turkey and are reflected in Attachment 1: "Table of the comments received from JMC members".

2. Decision:

1. JMC approves for financing 14 project proposals from the reserve list under the Second Call for Proposals Interreg-IPA CBC Bulgaria - Turkey Programme 2014-2020.
