1. Description:

The Written Procedure in accordance with Articles 7 (1) and 7 (2) of the Rules of Procedure of the JMC of the Interreg-IPA CBC Bulgaria – Turkey Programme for approval of the amendment of Pre-contracting report from the performed on the spot visits to the projects with works component and budget optimization and projects' content modification of the projects provisionally selected for financing and included in the reserve list under the Second Call for Proposals, was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 2 October 2019.

The official letter No. 99-00-2-454/02.10.2019 with the proposed document were sent to the JMC members via e-mail and made available in the JMC section of the Management Information System.

The amendment in the Pre-contracting report concerns correction of an identified technical error committed in the Negotiation protocols for projects with ref. No CB005.2.12.011 (with Lead partner Edirne Special Provincial Administration).

The JMC members were given 2 (two) working days to send their approval or comments on the proposed documents.
