### **1. Description:**

The Written Procedure in accordance with art. 7 of the “Rules of Procedures of the JMC” of the Interreg - IPA CBC Bulgaria – Turkey Programme 2014 - 2020 for approval of Negotiation Report for performed on the spot visits of the investment projects and the negotiations with the Lead partners of the projects provisionally selected for financing under the First Call for Proposals of the Programme was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 25.01.2017.

The official letter No 99-00-2-77/25.01.2017 and the attached documents were sent to the JMC members via e-mail and the JMC section of the Management Information System of the Programme for review.

The JMC members were given 10 working days to send their approval or comments on the proposed documents.

With reference to the written procedure a letter of complaint No 99-00-2-77(1)/31.01.2017 from the Lead partner - Primorsko-2004 Foundation, Bulgaria under the project “Conservation of natural and cultural heritage - benefits to people, nature and culture” with Ref. No CB005.1.21.127 was received during the JMC written procedure in the Managing Authority and was distributed to the JMC members on 01.02.2017 by email.

Approvals of the Negotiation Report for performed on the spot visits of the investment projects and the negotiations with the Lead partners of the projects provisionally selected for financing under the First Call for Proposals were received from the following institutions:

- Ministry of Tourism, Republic of Bulgaria;
- Ministry of Foreign Affairs, Republic of Bulgaria.

The names and institutions of JMC members together with summary of their comments are presented in Attachment 1.

No other comments were received in relation to the Negotiation Report for performed on the spot visits of the investment projects and the negotiations with the Lead partners of the projects provisionally selected for financing under the First Call for Proposals and letter of complaint from the Lead partner - Primorsko-2004 Foundation, Bulgaria concerning Project with Ref. No CB005.1.21.127.

**2. Decision:**

JMC approves the Negotiation Report for performed on the spot visits of the investment projects and the negotiations with the Lead partners of the projects provisionally selected for financing under the First Call for Proposals of the Interreg - IPA CBC Bulgaria – Turkey Programme 2014 -2020.


