Meeting under Interreg-IPA CBC Bulgaria – Turkey Programme held on 13 December 2018, Pomorie, Republic of Bulgaria

## 1. Description:

#### 2. Decisions:

The following decisions were taken by the JMC:

#### Decision 1:

The Joint Monitoring Committee approved giving the mandate to the Managing Authority to conduct pre-contracting procedures with all 42 provisionally approved projects and project proposals included in the reserve list under Priority Axis 2 "Sustainable Tourism".

## Decision 2:

The JMC approved giving the mandate to the Managing Authority, after finalization of the pre-contracting procedures and approval of the Pre-contracting report, to initiate consultations with the European Commission for amendment of the Programme concerning re-allocation of funds from Priority Axis 1 "Environment" to Priority Axis 2 "Sustainable Tourism", based on the amount of available funds and generated savings after signature of the contracts under the 2nd Call for proposals.

#### Decision 3:

The JMC approved the following modification of the complaint procedure on the technical and quality assessment and selection under the Second Call for Proposals: The technical grid, containing the average scores and

summarized comments of the assessors will be sent by the Managing Authority to all Lead partners under projects in the reserves list and rejected proposals as attachment to the notification letter for selection results. Therefore, complaint may be officially lodged not later than 7 working days after receipt of the notification letter for assessment and selection results.
