1. Description:

The Written Procedure in accordance with Articles 7 (1) and 7 (2) of the Rules of Procedure of the JMC of the Interreg-IPA CBC Bulgaria - Turkey Programme for approval of Technical Assistance Plan for 2020-2023 for Managing Authority (MA), Annual Technical Assistance Plan for 2020 for National Authority (NA), Indicative Technical Assistance Budget for 2020-2023 for MA and for 2020 for NA and Eligibility of Technical Assistance Expenditures for 2020-2023 of the Interreg - IPA CBC Bulgaria - Turkey Programme 2014 - 2020, was initiated by the Managing Authority - Ministry of Regional Development and Public Works, Bulgaria on 26 February 2020.

The proposed budget includes the expenditures of the Managing Authority (for 2020-2023), the National Authority (for 2020), and the Joint Secretariat - Haskovo (for 2020-2023), the Joint Secretariat branch in Edirne (for 2020) and the Certifying Authority (for 2020-2023) needed for the management and implementation of the Interreg - IPA CBC Bulgaria - Turkey Programme.

The JMC members were given 3 (three) working days to send their approval or comments on the proposed documents.

Approvals of the proposed amendment were received from the
