1. Description:

The Written Procedure in accordance with article 4, paragraph 2(d) and article 7 of the Rules of Procedure of the JMC of the Interreg-IPA CBC Bulgaria – Turkey Programme for **approval of request for extension of project implementation period of the project “Increasing attractiveness of municipalities Topolovgrad and Inece as ecotourism destinations” with reference number CB005.1.21.167, subsidy contract № RD-02-29-59/20.03.2017** was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 28.08.2018.


