1. Description: The Written Procedure in accordance with Article 7 of the Rules of Procedure of the JMC of the INTERREG-IPA CBC Bulgaria – Turkey Programme for approval of extension of project implementation period of the project “Increasing the cross-border tourism potential between Haskovo and Edirne (CrossTour)” with reference number CB005.2.22.093, subsidy contract № RD-02-29-179/23.07.2019, was initiated by the Managing Authority – Ministry of Regional Development and Public Works, Bulgaria on 21 May 2020.


