1. Description: The Written Procedure in accordance with article 7 of the Rules of Procedure of the Joint Monitoring Committee (JMC) of the Interreg-IPA CBC Bulgaria - Turkey Programme for consideration and approval of a proposal of the Managing and National Authorities (MA and NA) of the Interreg – IPA CBC Bulgaria – Turkey Programme 2014 – 2020 for empowerment of the Monitoring Committee to be established for (Interreg VI-A) IPA Bulgaria Turkey 2021-2027 programme to take decisions regarding the implementation and closure of the Interreg – IPA CBC Bulgaria – Turkey Programme 2014 – 2020 was initiated by the Deputy Minister of Regional Development and Public Works, Bulgaria and Co-Chairperson of JMC on 25.10.2022.

The official letter No. 99-00-2-259/25.10.2022 was sent to the JMC members via e-mail and made available in the JMC section of the Management Information System (MIS).

The JMC members were given 5 (five) working days to send their approval or comments of the proposal.

No comments were received from the JMC Members from both sides within the set deadline and therefore according to the Rules of procedure of the JMC the proposed empowerment of the Monitoring Committee to be established for (Interreg VI-A) IPA Bulgaria Turkey 2021-2027 programme to take decisions regarding the implementation and closure of the Interreg – IPA CBC Bulgaria – Turkey Programme 2014 – 2020 is deemed approved.

2. Decision: The Joint Monitoring Committee approves the empowerment of the Monitoring Committee to be established for (Interreg VI-A) IPA Bulgaria Turkey 2021-2027 programme to take decisions regarding the implementation and closure of the Interreg – IPA CBC Bulgaria – Turkey Programme 2014 – 2020.

The decision will take effect after the decision for approval of the (Interreg VI-A) IPA Bulgaria Turkey 2021-2027 programme by the European Commission, on the date of the official set up of the new Monitoring Committee.
